This packet is for each church's screening of its adult volunteers that will be present at Ascend Camp.

Ascend Camp

Church Volunteer Screening Requirements

As the primary leader of your church's student ministry at Ascend Camp, you are primarily responsible for the safety and welfare of your group members while at camp. This includes reasonable precautions to protect minors from sexual misconduct or abuse. We expect you to ensure that your leaders are adequately screened and evaluated, by completing each of the following tasks:

- Receive and review the **Church Volunteer Application** (included in this packet) for each of your volunteers.
- Require that a criminal and sex offender background check is completed for each volunteer using the information contained in the Church Volunteer Application, and the results recorded in your files.¹
- Affirm that each applicant is known to your church. The requirement that one must be "known to your church" can be satisfied by a person's regular attendance at your church for 6 months or by an interview process in which multiple leaders can verify that they know the individual has good character.

By signing the **Church Leader Screening Form**, you affirm that you have completed these requirements. Additionally, your Lead Pastor must sign the **Reference Form for Primary Leader of Student Ministry** and an authorized officer or representative of your church must sign the **Acknowledgement of Responsibility to Supervise**. These are the only 3 forms that you need to send us. Do not submit each leader's application or background check. (These should be kept in your ministry files.) By submitting the Church Volunteer Screening Form, you indicate that each of your adult leaders has been vetted by you in accordance with the above requirements.

¹ Numerous background check options are available. Background checks should be conducted by a reputable provider. Reference Form for Primary Leader of Student Ministry

Instructions: This form provides verification that the primary leader of your church's student ministry is reasonably qualified to manage the screening of all adult persons from their ministry who may volunteer to serve at Ascend Camp. This form needs to be filled out by the Senior Pastor (or Lead Pastor) in your church. If the Senior Pastor is the primary leader of your students at camp, then it needs to be filled out by another pastor or elder.

I have been advised that MY CHURCH conducts, through a third party service, a criminal history background check. I do hereby consent to this check being performed, and will agree to sign any additional authorizations that may be required by third-party services.

Ascend Camp Code of Conduct

Participant Church Leaders and Volunteers are present at Ascend Camp for the protection and oversight of students in their church. Each leader and volunteer must recognize that they are responsible to protect and supervise the students under their care.

Because of their position as role models, leaders must be very careful of their standards of dress, language, and conduct. Lewd, suggestive, or inappropriate behavior and language must be avoided completely.

Leaders must take all reasonable care to ensure that no adult leader or volunteer ever:

- physically, verbally, sexually, or emotionally abuses children or youth, nor cultivates relationships in order to initiate or hide abuse.
- Is alone with a child or young person in an isolated location.
- touches children or youth in a manner which is inappropriate given their age, gender, cultural background, context or personal circumstances.
- physically disciplines a child or young person in the course of their ministry.
- makes alcohol, cigarettes or illicit drugs available to children or youth.
- becomes romantically involved with any children or youth.
- views, possesses, produces or distributes material containing inappropriate language or graphic depictions of sexual acts or nudity; or views possesses, produces or distributes any form of child pornography or child exploitation material.
